HELPING BUSINESS TO RECYCLE

A training workshop for Councils and the Waste/Recycling Collection Industry

- Monitor and review progress being made by a business owner to reduce waste and increase recycling

The workshop content will cover information such as:

- Waste policy and resource recovery legislation
- The commercial & industrial waste stream
- Common resource recovery barriers and drivers for small and medium businesses
- Introduction to and training in the use of the Bin Trim tool
- Waste reduction and recycling for small to medium businesses
- Waste reduction and recycling options for each industry sector
- Waste reduction and recycling options for a variety of waste materials
- Best Practise Resource Recovery case studies
- An overview of how materials are recycled
- Support Resources – including a copy of the Bin Trim tool and fact sheets

Workshop material: Each participant will be provided with a manual and Bin Trim resources to help you support your business customers to waste less and recycle more.
